Stallion Service Contract

This contract is between Wendy Bauwens (the Stallion Owner), and:

Fees paid in this contract are for the breeding of the aforementioned mare only. Substitution of another mare must be discussed and approved by stallion owner and shall require the same pre-breeding exams and testing.

Mare owners will ensure that the mare named in this contract is healthy and in sound breeding condition and free from infection or disease. All mares require veterinary documentation of a recent clean uterine culture and cytology. We strongly recommend that mares undergo a full breeding examination prior to breeding (which includes an ultrasound), AND undergo breeding services in optimum physical condition and weight in order to ensure the highest possible rate of conception.

For live cover breeding, mares must be current on all vaccination and deworming protocol, Coggins testing, and present a health certificate upon arrival at Sunnyside Farms. Hind shoes must be removed. In case of any illness or injury to the mare, the mare owner agrees that a suitable course of treatment may be undertaken by Sunnyside Farm's Veterinarian, at the mare owner's Expense. Every attempt will be made to contact mare owner before initiating any treatment. The stallion owner shall not be responsible or liable for any accident, illness or injury to the said mare or her foal.

For fresh semen shipments, we ship two doses with an additional dosage fee of \$500/dose if mare needs additional service during the breeding season. The mare owner is responsible for hauling, collection, shipping and container rental fees (approximately \$600) arranged and payable directly to the serving veterinary clinic. Depending on the stallion's location, semen will be shipped by Summit Equine if in Oregon, Montana Equine if in Montana or Arizona Equine if in Arizona. Some clinics only collect and ship on specific days of the week. Prior arrangements with the clinic must be made in order to coordinate mare ovulation and semen collection/shipment and insemination.

For frozen semen, we ship two doses (8 straws each) from Sleeping Giant Genetics in Livingston, Montana. There will be a dosage fee of \$500 per dose if said mare needs additional service during the breeding season. The mare owner is responsible for hauling, shipping and container rental fees arranged and payable directly to the serving veterinary clinic.

All breeding mares shall be checked for pregnancy and twinning at the mare owner's expense (unless otherwise discussed and agreed) at approximately 14 days post-breeding. Mares shall be rechecked at 30 days for a foal heartbeat.

Fees

The total breeding fee is \$2,500. A non-refundable booking fee of \$1250 is due with the return of this contract in order to secure the breeding. The balance of \$1250 is due at the time the mare is confirmed in foal at the farm for live cover OR when the semen is shipped for AI. Mare care fee is \$15 per day. Service fee, mare care, vet bills, and any other outstanding fees must be paid before the mare leaves the premises. AI fees such as collection and shipping are the responsibility of the mare owner and may vary.

Diligent effort will be made to settle the mare. However, if for any reason she does not settle, the Stallion Owner will not be held liable. If the mare doesn't settle by the end of the breeding season (September 1, 2023), no future breedings shall be attempted that year. The mare owner shall forfeit the \$1250 booking fee at this time but may try again the following season with the same requirements as stated in this contract.

This breeding contract includes a Live Foal Guarantee (LFG). If, for some reason, the foal is not born to stand and suckle within 2 hours of birth, the mare owner shall have an opportunity to repeat this breeding. Should the mare become ill or die during foal gestation period, another pre-approved mare may be used. Provided a foal is born, standing and suckling, a Certificate of Service shall be provided to the mare owner for the foal's registration. No other guarantees shall be made.

Refunds

In the event that the selected stallion should die, become lost, stolen, or unfit for breeding (per veterinary inspection) prior to breeding the mare, the mare owner is entitled receive a full refund and this agreement becomes null and void. **In this case only**, the mare owner has has the option to transfer this agreement to another stallion with the same or a different approved mare.

This breeding contract is subject to interpretation under the laws of the State of Montana, Oregon and Arizona and any disputes regarding it must be brought in a court of lawful jurisdiction in the county of service.
